Medical Appliances and Assistive Technology FY2020 and FY2021: \$500,000 GF/MH

Technology has the potential to enrich the lives of Trust beneficiaries by improving access to home, community, and work in a more independent way, allowing individuals to age independently at home in a safe environment. Sensory impairments have a greater negative impact on Trust beneficiaries in their development, daily life functioning, safety, and independence.

Proposed funding will be used to expand access to medical appliances and assistive technology needed by beneficiaries experiencing low vision, blindness, hearing impairments, and deafness. Funding can also be used to purchase items to improve health and safety of Trust beneficiaries who have limited resources.







Coordinated Transportation \$1,000,000 GF/MH, \$300,000 MHTAAR FY2020 – FY2021

What is Coordinated Transportation?

The Department of Transportation and Public Facilities provides grants to local community providers for coordinated transportation in their communities.

Grant funds support the purchase, modification, and maintenance of vehicles for coordinated transportation. These funds also support transit programs tailored to meet the needs of beneficiaries, such as taxi vouchers, and the community. The local transportation plan guides these programs.

An ongoing capital program managed by the Department of Health and Social Services, the Essential Program Equipment program provides agencies serving Alaska Mental Health Trust Authority beneficiaries with grants to purchase equipment to ensure services provided are safe and of good quality.

Grants of up to \$25,000 are made to eligible and successful applicants to purchase appliances, safety equipment, computers, recreation equipment, and other program necessities.






