
### Mission


## Dementia Collaborative Workgroup

#### **10-YEAR GOALS**

- 1. Expand services options and capacity
- 2. Establish a dementia-capable workforce
- 3. Create resources and information
- 4. Establish the importance of prevention and early diagnosis
- 5. Develop a system to monitor ADRD prevalence and impact of initiatives
- 6. Promote innovation and research

#### **FY2022 PRIORITIES**

- Expand access to services through increased funding
- 2. Strengthen the dementia capable workforce
- 3. Enhance Caregiver support and direct services
- 4. Increase awareness and engagement



### Alzheimer's Disease Programs Initiative

- Grants to states funded by the Administration for Community Living (ACL)
- Programs include significant direct service components and include implementation of evidence-based interventions.
- Projects were funded to develop dementia-capable systems to provide quality, person centered services and supports that help individuals remain independent and safe in their communities.

## Support for Complex Behaviors

## ANCHORAGE PIONEER HOME COMPLEX BEHAVIOR NEIGHBORHOOD

- New neighborhood opening at the end of 2021
- Eligible to individuals 60 and over with complex behaviors related to dementia
- ➤ 9 residents, 3 direct care staff and 1 nurse during the day, 2 direct care staff and 1 nurse at night
- Must be on the Pioneer Homes waitlist

#### HOPE RESOURCES FOREST HOME

- Assisted Living Home developed to support individuals transitioning from API who have complex behaviors related to dementia.
- Unable to support additional recipients due to workforce shortages.

Disturbing trends in senior care are leading to increased costs and fewer options for individuals with ADRD and their caregivers

62% increase in senior population between 2011 and 2020

Average cost per individual for HCB waiver services in 2020 was \$38,308

Average cost per individual for nursing home care in 2020 was \$162,108

25.9% decrease in home and community-based waiver services between 2011 and 2020

18.7 % increase in nursing home care between 2011 and 2020

## Home and community-based services are the KEY



- Develop a reliable dementia capable workforce
- Increase rates for direct service workers and care coordinators to recruit and retain workforce
- Assess the needs of family caregivers and provide adequate support
- Develop a statewide marketing campaign to raise awareness of Alaska's Aging and Disability Resource Centers
- Adopt a resolution to make ADRD a public health priority with specific targets that are evaluated annually
- Develop a specific eligibility category that allows individuals with ADRD to qualify for the Medicaid Waiver.
- Transition individuals with ADRD in API and Department of Corrections into appropriate settings.
