2018

Federal approval (CMS) for SUD component of 1115 Medicaid Waiver

Initial conversations about Crisis Now framework in Alaska

Behavioral Health Improvement Project focuses on psychiatric boarding in emergency departments

2019

Forensic Psychiatric Hospital Feasibility Study completed

Federal approval (CMS) for behavioral health component of 1115 Medicaid Waiver

RI International conducts Crisis Now implementation readiness assessment in Anchorage, Mat-Su and Fairbanks

Statewide convening on behavioral health crisis continuum

First site visit to Arizona to see Crisis Now in action

2020

Community planning workgroups convened in Anchorage, Fairbanks and Mat-Su

Concept-level pro formas developed for crisis services

SB 120 amends Title 47 to include crisis stabilization centers as locations for emergency detention

Settlement agreement with Disability Law Center identifies Crisis Now as a systems improvement initiative

2021

Crisis Now community coordinator positions funded in Fairbanks and Mat-Su

Mobile crisis teams launch in Anchorage and Fairbanks

2022

HB 172 signed into law





Statewide Call Center: Careline



- Answers 988 calls dialed from a 907 area code and calls to Careline number (877-266-4357)
- 3-fold increase in call volume since 988 launch in July 2022
- Averaging 4000+ calls a month/Second office in Wasilla Opened
- MCT pilot dispatch from Careline in the Mat-su later in FY 25
- Established backline for receiving transfers from PSAPs





Anchorage

- Municipality of Anchorage
 - New administration
 - Anchorage Fire Dept, Integrated Mobile Response Team averaging 3,500-4,000 dispatched calls a year
 - 90% successful resolution in community
 - Anchorage Police Department, Mobile Integrated Teams data is forthcoming
 - 911 Dispatch behavioral health calls transferred to Careline
- Crisis Stabilization
 - Providence Spring of 2026
 - Southcentral Foundation Phased approach in 2026

Mat-Su Valley

- True North Recovery- Mobile Crisis Team
 - Expanded reach
 - 583 crisis call outs Palmer/Wasilla 85.7% stabilized in community; 12% to Hospital; 2% law enforcement
 - Hope Line 2,500+ calls taken by the MCT and TNR team
- Mat-su Behavioral Health Crisis System/20+ agencies
- Dispatch Matcom/EMS/Palmer PD/AST
- Careline Crisis Line (satellite location)/expanded MCT dispatch through Careline, in development
- Crisis stabilization beds at TNR and Set Free
- Launchpad clients over 900 to date 2024





Fairbanks

- Alaska Behavioral Health Mobile Crisis Team
 - 744 dispatches (Oct/23-Sept/24) -85% resolved in community, 2% LE resolved, 13% hospital
 - 92% of the dispatches were solo (meaning no LE needed)
 - Referrals:273
 - Follow-ups:195
- MCT working with COF, North Pole, and AST LE
- Crisis Stabilization City of Fairbanks working with AKBH/Trust for "no wrong door" Crisis Center
- Pediatric Crisis Beds at FMH in planning

Juneau

- Capitol Fire/MIH team: 1519 dispatches in 2024 up through October, and triaged 1,197 crises over the phone during this same time
- Juneau Police Department dispatch is using the Careline backline to transfer behavioral health crisis calls
- MIH team is working with grant support to fund a behavioral health clinical staff to work with the MIH team- this will improve assessment and clinical transitions within the community
- On-going discussion with partners on crisis stabilization services for the region



Ketchikan

- MIH team officially launched in June/2024 from the KFD
- MIH has reduced targeted high utilizers 911 use by 40% as compared to the previous quarter
- 70 dispatches and 13 public outreach events in 1st quarter
- Crisis case management and crisis peer services launching in December 2024- True North Recovery








Kenai Peninsula

- Central Peninsula Hospital
- Nikiski Fire Department MIH team: 339 dispatches
- Expanded health powers for the MIH team by joining CPH
- January immersion trip to AZ

Kotzebue


- Crisis Now TA with Agnew::Beck in support of Maniilaq for planning a crisis system of care
- Phase 1: Design, Planning, and Implementation for EmPATH unit within the hospital in Kotzebue
- Phase 2: Design, build, and launch of a "no wrong door" crisis stabilization center in Kotzebue





Copper Basin

- 355 Trust beneficiaries served through the MIH team
- Behavioral health needs assessment 2023
- Sustainability of the MIH team has transitioned into working with local community health aids, versus a paramedic/health aid model



Unalaska

- Community For Community (C4C)
- Monthly meetings since 2023
- Collaboration of community partners, tribal and nontribal
- Partnership with UAA/AKTC for training on best practices for responding to behavioral health crisis
- Trust program officer involvement on the C4C

 - State-wide rate methodology/actuarial
 - 1115 BH Medicaid waiver/State plan amendments
 - Milliman Report: Assessment of AK BH Crisis Services Continuum of Care 6/24

Data, System Monitoring and Care Coordination: Alaska Efforts and Needs

- 2019 RI Consultation Report, Recommendation: Establish performance expectations and metrics, along with the data systems to collect the information
- 2020 Crisis Now Community implementation logic models (Anchorage, Mat-Su, Fairbanks)
- 2023 Crisis Now component logic models: community level data reporting for performance monitoring (in progress)
- 2024 Identification of platform(s) to standardize data and information sharing across levels of monitoring (in progress)





Next Steps.....

- Continue to partner with DOH/DFCS/APS/etc. on providing policy, funding, and programmatic support to the functionality of the crisis system of care.
- Work with Agnew::Beck and other contractors to bring forward the Crisis Now model and/or approximations of that model.
- Collaborate with provider agencies/trade associations on advocating for policy changes needed to make these services viable.
- Ensure systems for data monitoring and care coordination are executed fully.
