The Alaska Office of Children's Services (OCS) supports the Alaska Impact Alliance (AIA)'s proposal to the Alaska Mental Health Trust Authority for the Early Childhood Intervention and Prevention grant. We understand that through the proposed project the AIA will expand and enhance its existing programs and projects augmenting budgeted State of Alaska funds designated to AIA. The funds will support the capacity building efforts and direct supportive opportunities for families involved with or at risk of involvement with OCS. OCS supports the AIA's proposal to expand and flexibly respond to families and children in foster care or at risk of removal by using these funds to support families and children through mini-grants for basic needs, respite, mental health consultation and other supportive services in a timely meaningful manner.

OCS works to ensure the safety and well-being of children in the State of Alaska. OCS receives, screens, and investigates reports of allegations of child abuse and neglect. OCS works with families to safely maintain children in their own homes, through referrals for services for families which connect them to community resources. OCS also is required to intervene legally if it is determined children are unable to remain safely in their own homes. In these cases, OCS provides out-of-home placements and permanency planning. In the last five years, OCS has received an average of 21,000 protective service reports per year, with an annual average of 9,600 cases screened in for services. Through adaptive, family-focused responses, we carry out our mission: ensuring the safety, permanency, and well-being of children by strengthening families, engaging communities, and partnering with Tribes.

The AIA's proposed project responds to a high level of need in our state for robust support for young Alaskans and their families with a lens of early intervention and prevention. OCS strongly supports the expansion of AIA's resources available for concrete supports, supportive services, resource navigation and early intervention efforts.
