MEMO

Attached for your information is a summary of Alaska Mental Health Trust Authority grants awarded in the fourth and final quarter of FY22. Between April 1 and June 30, 2022, the Trust designated \$2,310,752 in grants to organizations and partners that serve our beneficiaries. In FY22, the Trust has awarded \$3,745,999 in authority grants that are \$100,000 or smaller.

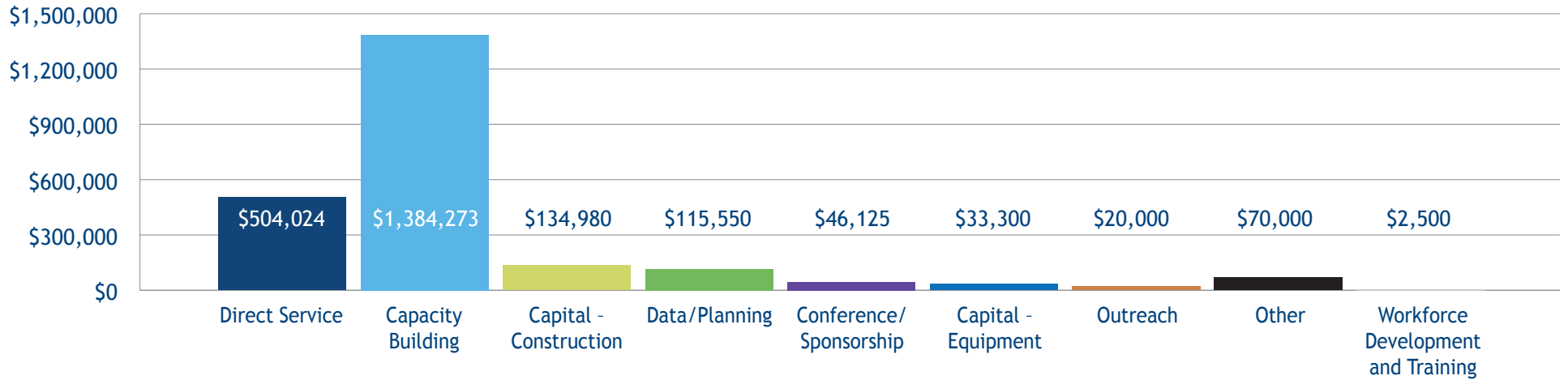

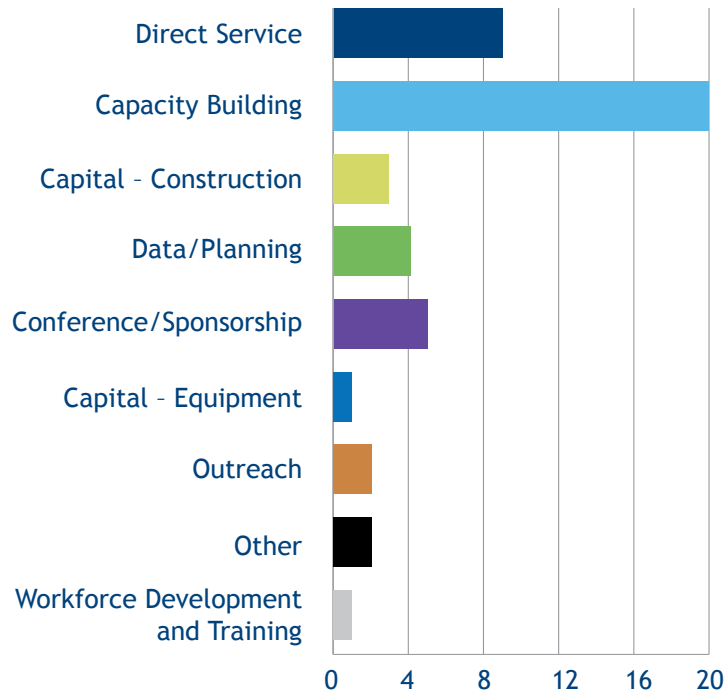

Alaska Behavioral Health (AKBH) will use Trust funds for their peer support specialist (PSS) apprenticeship program that is being operationalized this year. AKBH is partnering with the State of Alaska Department of Labor and Workforce Development (DOLWD) and the Division of Behavioral Health (DBH) on setting up the first PSS apprenticeship program in the state. DOLWD is working with AKBH to align the apprenticeship model with the federal DOL model. While DOLWD and DBH are both helping fund this work, Trust support will help with replicating this model in other agencies across the state. ARA delivers a robust array of dementia education, teaching best practices in dementia care to anyone interested, including family, professional caregivers, and those working in the field of dementia care. They administer Alzheimer's disease and related dementia (ADRD) mini grants for the Trust and provide individual consultations and support groups for people who have ADRD and their caregivers. ARA also provides Medicaid waiver care coordination services through an affiliate organization, Care Coordination Resource of Alaska (CCRA).</p> <p>Trust funds will allow ARA to hire an executive search firm to recruit and assist ARA in filling its opening for the Chief Financial Officer (CFO) position, which will assist the organization in finding a CFO that is a good fit for skills and longevity. With help from Trust funds, Ready to Rent will provide beneficiaries who are exiting homelessness with housing education, essential household items, and daily life skills to achieve a life of self-sufficiency. Beneficiaries who have experienced homelessness often need assistance remaining stably housed. Ready to Rent will also teach or refresh the skills people need to be a successful tenant. This will complement the HUD Permanent Supportive Housing programs that serve homeless individuals and families who are also Trust beneficiaries. This project aligns with the Trust's Housing and Home & Community Based Services focus area work to help Trust beneficiaries attain and maintain affordable housing. It is a critical, non-clinical supportive and educational service to help Trust beneficiaries exiting homelessness and ensures that new tenants have the basic household items needed to effectively live in an apartment setting. AAHA offers a comprehensive and innovative training and technical assistance program for Indian Housing Block Grant recipients. The services are delivered in close collaboration with the Alaska HUD Office of Native American Programs (HUD ONAP), Alaska Regional Housing Authorities, and housing experts. <p>Cache Integrity Services (CIS) is a valued Trust partner who successfully used Trust funding to stand up valuable payee services for the last two years. CIS is requesting funding for a nonprofit Guardianship Pilot Project. Guardianship is a legal arrangement where an individual or institution is appointed by the court as a guardian to represent and/or make decisions on behalf of an incapacitated person or someone who is unable to represent and/or make decisions for themselves. Guardianships can be for housing, medical care, legal issues, services, and financial matters. Guardians serve all Trust beneficiary groups in Alaska who require the added support and assistance in their lives. Typically, guardianship services are provided by family or friends, private professional guardians for those who can afford their services, or the State of Alaska through the Office of Public Advocacy (OPA) if no other suitable option exists. Due to OPA Guardians having high caseloads of between 65 to 90 cases and a lack of private professional guardians, there is currently a need for additional options. CIS will be able to fill this need by partnering with OPA and utilizing a sliding fee scale to accept cases with nominal resources that otherwise could not afford a traditional private, professional guardian. The documentary will look at this issue using interviews of therapists, patients engaged in treatment, and the families who will share their lived experiences of living with addiction and trying to get help. Finding adequate behavioral health services in Alaska is challenging, and even more so in remote villages. Gaps in funding, legislation, and health care providers make it especially hard for those seeking sobriety and long-term addiction recovery. Centers for Independent Living serve individuals with a disability of any kind who want additional support with services, technology, or income so they can remain in their home communities to live the lives they choose. They are experts on accessing the home and community based service system. The Independent Living Center (ILC) is the Center for Independent Living for the Gulf Coast Region in Alaska. Though ILC does not employ case managers, the Independent Living (IL) Advocates are familiar with service coordination and the additional advocacy efforts needed for individuals with Traumatic and Acquired Brain Injuries (TABI) and their families. The Gulf Coast TABI Expansion Project will provide resource facilitation, peer mentorship, and support to individuals experiencing TABI, their families and caregivers who reside in the Gulf Coast region: Kenai Peninsula, Kodiak Island, and Valdez/ Cordova census area. The ILC's Independent Living Advocates trained by this project will provide outreach in these communities, join the TABI Advisory Council meetings, and work with the University of Alaska Anchorage (UAA) Center for Human Development and other TABI grant recipients. Covenant House Alaska (CHA) provides shelter services for youth ages 13-24 and manages housing, education, and support service programs for youth. Anchorage is one of the most diverse communities in the country and to better serve youth who are Black, Indigenous, and People of Color (BIPOC), CHA developed a diversity, equity, and inclusion (DEI) department. CHA's DEI department was created to formalize the processes that ensure diversity, equity and inclusion are central to all program design, creation, implementation, and on-going evaluation. The department has its own director, a 12-person DEI committee made up of diverse CHA staff who work on DEI-related projects within the agency, and a new Youth Fellowship position which is a one-year, full-time, paid staff position with benefits for a young person utilizing these programs who serves as a voting member of the board of directors. Trust funds will support the CHA Culture Coordinator and DEI Department project. This project will dramatically advance CHA's work to make sure every youth is meaningfully and equitably served. A majority of homeless youth are Trust beneficiaries, with the most common categories being beneficiaries experiencing a mental illness and addiction. Trust funds will blend with Child Welfare Academy funds to support three trainings by the National Family Support Network to be offered to AIA members in 2022. These trainings will support certification of agencies who are interested in starting or further developing resource centers for families in their communities. Members have expressed a high level of interest from around the state and are eager to engage in this work. Juneau's unsheltered homeless population-those who live on the street, in cars, area parks, abandoned buildings, and encampments-have reduced access to Juneau's Coordinated Entry System (CES) as compared to Juneau's sheltered population. Many are unsheltered as a result of substance abuse and mental illness, which can result in being trespassed from Juneau's emergency shelters. Trust funding will support Coordinated Street Outreach in Juneau, providing unsheltered persons immediate access to services and access to monthly community case conferencing meetings with the goal of supporting them along pathways toward housing stability through Juneau's CES. This is a shared database and cooperative interagency practice established to create a prioritized waiting list for housing from those who are engaged in the homeless services system, including street outreach. It is important to understand how many people are homeless and what needs they have so that the community can respond with interventions that match people's needs.
