





Trust Lands Timber Assets

- Approximately 250,000 of timber statewide.
 - 60,000 southeast
 - 60,000 southcentral
 - 100,000 plus in interior
 - The timber lands are currently being mapped statewide for the carbon market.

Timber Sales from 1995 to present have Generated over \$60 Million in revenue


- This was nearly entirely from the old growth forest of southeast Alaska.
- There is very little current traditional market value in the forest of southcentral and interior timber on Trust lands.

•Alaska Mental Health Trust Land Exchange Act of 2017

- January 2019 Phase 1 Completed
 - 2,508 Trust acres in Ketchikan
 - 2,425 Federal acres in Naukati
- April 2020 Phase 2A Completed
 - 3,200 Trust acres near Ketchikan
 - 1,513 Federal acres in Naukati
- August 2021 Phase 2B Completed
 - 12,262 Trust acres in Ketchikan, Petersburg, Wrangell, No Name Bay, Meyers Chuck, Sitka, Juneau
 - 14,555 Federal acres in Naukati, Hollis, and Shelter Cove
- January 2022 Access Easements
 - Total of 17,980.19 acres of previously Trust land in FS ownership and 18,491.96 acres of previously Federal land in Trust ownership.

We have completed 90% of all the old growth timber harvest

- Naukati Contract signed with Viking March 2017
- This sale will likely be competed 2025.
- Shelter Cove contract signed with Alcan 2022. This sale will likely be completed in 2026 - 27.





The Trust has 60,000 of highly productive forest in Southeast with varying aged stands of timber.




Timber stand that was never (PCT) precommercial thinned.



Overstocked and stagnant




PCT -Thinned by the USFS prior to our ownership





Managing the Trust Forest for the future generations.

- Active management of the forest is essential to a responsible and profitable future.
- Pre commercial thinning of young regenerating stands of trees is essential to optimal growth and health.
- We are currently using the carbon marketing to map and inventory what stands will need to be pre commercial thinned.
- We believe there is at least 5000 7500 acres that need to be thinned.
- NRCS will possibly pay to complete this thinning if we have a native entity manage the thinning contracts.
- This could be worth millions of dollars to assist in thinning the forest stands.

- Complete the mapping of the three regions of the state.
- Decide on what lands and forest to include in the carbon market.
- Inventory the forest lands to be considered for carbon.

Decide on a marketing approach for selling carbon.

Cleaning up flying is a mission of improbable scale: Neutralize the carbon emissions of about 25,000 planes in the world's commercial fleet that typically ferry some 4 billion people a year and burn close to 100 billion gallons of jet kerosene Alaska Air uses 750,000,000 gallons a year.
